## 4 – FIRST-AID MEASURES

**BREATHING (INHALATION):** Remove from exposure area to fresh air immediately. If breathing has stopped, perform artificial resuscitation. Keep person warm and at rest. Treat symptomatically and supportively. Seek medical attention immediately. Qualified medical personnel should consider administering oxygen.

**SWALLOWING (INGESTION):** Give large amounts of fresh water or milk immediately. Do not give anything by mouth if person is unconscious or otherwise unable to swallow. Ethylene glycol can cause central nervous system depression and metabolic acidosis. Consider removal by gastric lavage. Blockade of the diacid/hydroxyacid metabolites may follow competitive inhibition of alcohol dehydrogenase with ethanol or 4-methyl pyrazole. Consider maintenance of a plasma ethanol level of 100 mg/dL to 150 mg/dL.

### 5 – FIRE-FIGHTING MEASURES
